Terms of payment: 50% deposit payable on confirmation of order.

Balance due on completion (unless otherwise negotiated), prior to collection or delivery.

- 1) Quotation or Estimate valid for 30 (thirty) days and is subject to final content, the availability of materials and price increases.
- 2) All prices exclude VAT (at 14%) unless otherwise stated.
- 3) All prices are quoted in ZAR and invoices are payable in ZAR.
- 4) Any deposit received on confirmation of an order is non-refundable.
- 5) All pricing is subject to change without prior notice. All signed orders on which a deposit has been received will be honored at the quoted price.
- 6) Rush jobs (orders required within less than 10 working days) will be subject to a surcharge of 15% of the total before VAT.
Rush jobs will be accommodated where production schedules allow.
- 7) Cash and EFT payments will be regarded as received as soon as they reflect in our account or proof of payment is received. Cheque payments will only be deemed as received once cleared. Note that cheques can take up to 7 working days to clear, which may cause delays.
- 8) Variations on specifications of any kind (from supplied quotations) will result in a revision of the quotation.
- 9) Before proceeding with any designs, layouts etc., a signed-off quotation/order is required.
- 10) It is the responsibility of the client to sign off all artwork prior to going to print.
- 11) RubyGrey Creative will not accept any responsibility for errors, omissions or otherwise as a result of artwork not being signed off.
- 12) Mock-ups are optional. However, they are recommended to ensure that all parties are in agreement on materials to be used. RubyGrey Creative will not be held responsible for any misperceptions arising as a result of any orders placed without the request of a mock-up.
- 13) Additions required will be quoted for on request.
- 14) All logos, copy and other content to be supplied in required formats.
- 15) All artwork **includes 2 (two) authors changes**, after which additional artwork charges will apply at R320/hour.
- 16) Lead time: minimum 3 (three) weeks required (unless otherwise negotiated) for print and assembly.
- 17) The customer indemnifies RubyGrey Creative against any claims, costs and expenses arising out of the infringement of copyright, trademarks, patent or design.
- 18) All items will remain the property of RubyGrey Creative until full & final payment is received.
- 19) Any costs incurred in the recovery of debt will be for your account. Interest incurred on overdue amounts not paid as per invoiced terms will be charged for at prevailing bank rates.
- 20) All artwork and designs remain the copyright of RubyGrey Creative and may not be reproduced in any way, in part or full without written consent from RubyGrey Creative.

Cancellation Policy

- 1) Deposits are non-refundable. In the event of a cancellation of an order, any deposit amount paid will be forfeited.
- 2) Should the cancellation of an order be received once an order has been completed (either partially or in full), the balance and/or full invoiced amount shall be payable.
- 3) Changes to quantities ordered: Quantities as per your order will be regarded as minimum quantities and cannot be reduced. Additional items may be ordered.
